subject: COVID-19 – Fair Work Commission – Job Keeper Scheme Update

Dear Lifebridge Staff and Volunteers,

As we move into another quiet weekend, we take this opportunity to provide the following information and reminders for the week ending 3<sup>rd</sup> April 2020.

## **General Update**

- We are pleased to confirm that as of this afternoon there are no reported or confirmed cases of COVID-19
  amongst our staff, customer and/or carer population. Where staff or customers have been tested, all have
  returned negative results. Please note that many Lifebridge staff and volunteers have elected to self-isolate for
  personal or family reasons or because they fall into a high-risk category.
- We remind staff and volunteers of their responsibility to adhere to all social distancing and hygiene protocols
  over the weekend. Please keep yourself, your family and your community safe during this period. Maintaining
  appropriate hygiene and social distancing practices will increase our chances of preventing exposure and
  infection in the community and in turn enable us to provide much needed supports to our aged and disability
  customers on an ongoing basis.
- Lifebridge have secured and continue to make available personal protective equipment and product to be used in the provision of supports for the protection of our customers, co-workers and families. PPE and products including gloves, face masks, waterproof booties, hand sanitiser, disinfectant and hand towels are available at our Kingscliff offices, Monday Friday 8.30am 3.30pm. Wherever possible, please bring your own dispensers to be refilled from the bulk products we have sourced.
- The Lifebridge Executive remain in constant contact with government departments, peak bodies and agencies to ensure we are up to date on all legislative changes and relief packages being made available. The following is a quick summary of two key initiatives we are keeping a close eye on:

#### Fair Work Commission

The Fair Work Commission is conducting a hearing on the  $6^{th}$  April, 2020 to review submissions for the introduction of new temporary clauses to be included in 103 Modern Awards. There are two key amendments under consideration, likely to come into effect  $8^{th}$  April – 30 June 2020.

- 1. Annual Leave can be taken as half pay ie. can take twice as much leave at ½ pay.
- 2. Two weeks unpaid Pandemic Leave.



Please be advised that Lifebridge has already implemented the above initiatives enabling staff to self-isolate upon request accessing all or part of their accrued annual leave or LWOP.

# Job Keeper Scheme

The Government is introducing a subsidy program to support employees and businesses.

The Job Keeper Payment is designed to help businesses affected by the Coronavirus to cover the costs of their employees' wages, so that more employees can retain their job and continue to earn an income. Please see attached the latest **Job Keeper Fact Sheet** which outlines how this scheme will work, eligibility criteria and likely timeframe for implementation.

Please note that Lifebridge has registered with the ATO and is currently awaiting further advice to determine eligibility for the scheme.
